RESOLUTION REQUESTING THE GOVERNOR TO APPOINT
WILLIAM CAPPUCCIO AS BUENA VISTA REGIONAL MUNICIPAL COURT
JUDGE

WHEREAS, there has been established pursuant to N.J.S.A. 2A:8-3 a Regional Municipal Court for the Township of Buena Vista and Weymouth Township, Atlantic County, New Jersey; and

WHEREAS, Judge William Cappuccio currently serves as the Municipal Court Judge for the Buena Vista Regional Municipal Court; and

WHEREAS, N.J.S.A. 2A:8-5 requires that the position of Judge of a Regional Municipal Court shall be filled by the nomination and appointment of the Governor of the State of New Jersey with the advice and consent of the Senate and State; and

WHEREAS, the Governor and the Senate have yet to act on this existing appointment.

NOW, THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Weymouth Township, County of Atlantic and State of New Jersey that the appointment of Judge William Cappuccio be restated by this Township Committee and that a recommendation is herewith made to the Honorable Governor Chris Christie, Governor of the State of New Jersey, for the appointment of William Cappuccio, Esq. as Judge of the Buena Vista Regional Municipal Court which serves Weymouth Township, in accordance with N.J.S.A. 2A:8-5, which appointment is respectfully requested.

BE IT FURTHER RESOLVED that a certified copy of this Resolution shall be forwarded forthwith to the Honorable Chris Christie for his immediate consideration in filling the position aforesaid by recommendation to the Senate of the State of New Jersey
