ORDINANCE NO. 518-2013

**AN ORDINANCE AMENDING SECTION 142 (GARAGE SALES) OF THE CODE OF THE
TOWNSHIP OF WEYMOUTH**

WHEREAS, the Township Committee of the Township of Weymouth, Atlantic County, is of the opinion that the public interest will best be served by adopting amendments to §142 of the Code of the Township of Weymouth;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Weymouth in the County of Atlantic, State of New Jersey, as follows:

1. Chapter 142 of the Code of the Township of Weymouth (Garage Sales) is hereby amended as follows (deleted language is ~~stricken~~; additional language is underlined):

§142-1. Definitions.

GOODS – Includes any second hand goods, or other property capable of being the object of a sale regulated hereunder.

§142-2. License required.

No Change.

§142-3. License fee.

A fee of \$5 \$10 shall be charged for each garage sale license, payable to the Township Clerk.

§142-4. License restrictions.

Such license shall be limited to ~~one license~~ three (3) licenses per dwelling unit within a twelve-month period. No such license shall be issued for more than ~~three~~ two (2) consecutive days. For purposes of this section, a license issued to one other than the owner of a property shall be deemed to be issued to that owner as fulfilling his license entitlement for the twelve-month period. Each license issued under this section shall be prominently displayed on the premises upon which the garage sale is conducted throughout the entire period of licensed sale. No “rain dates” or other alternative dates shall be permitted for any licensed sale.

§142-5 through §142-10.

No Change.

2. **Severability.**

If any Article, section, subdivision, sentence, clause or phrase of this Ordinance shall be held to be invalid for any reason, such decision shall not affect the remaining portions of this Ordinance.

3. **Repealer; Exception.**

All Ordinances or parts thereof or Resolutions inconsistent with the provisions of this Ordinance are hereby repealed to the extent of their inconsistency. Nothing in this Ordinance, however, shall affect the rights and tenure of any elected official.

4. When Effective.

This Ordinance shall take effect immediately following its advertisement, public hearing and adoption in accordance with the law.

IT WAS THEN FINALLY ADOPTED.
